Alumnus Timothy Heath "Tim" Simmons graduated from Southern Colorado State College, now CSU Pueblo, in 1969 with a bachelor's degree in mass communications and a minor in business. He continued his post-graduate studies at the University of lowa, where he earned a master's degree in journalism with a minor in athletics administration.

Simmons went on to have an astounding career in sports public relations for collegiate, Olympic, and professional teams, including the Denver Nuggets. After serving in sports marketing for Coors Brewing Company, Simmons "retired" and established himself as an independent consultant in media information for sporting events traveling across Colorado, the United States, and the world.


As the son of legendary Southern Colorado State College basketball head coach, Harry "The Chief" Simmons, Tim grew up on the SCSC Orman Campus and identifies as a Pueblo boy, no matter where he lives. His love of CSU Pueblo and its athletic programs can directly be attributed to his dad and time spent with him on campus.

Simmons and his wife, Lynn, met thanks to a former player of the elder Simmons and have been married for 48 years. She understood the Simmons humor and wit and was a perfect match. Lynn spent 25 years working in elementary education and is now a consultant working with educational staff development.

Tim's consulting and travel schedule is hectic at best, but he manages to give generously of his time to CSU Pueblo. He serves as the Athletics Hall of Fame Committee chair and Athletics historian. Recently, he introduced and now manages a regular email communique to friends and followers of the Pack - The Howler Herald. He also regularly hosts CSU Pueblo Basketball Alumni events in the Denver Metro area and serves as a Sustaining Trustee for the CSU Pueblo Foundation.

Todd Kelly, Jillian grew up on campus attending sports camps and watching the ThunderWolves athletes play when her dad was working as the associate athletic director in the **CSU Pueblo Athletics** Department. She looked up to the CSU Pueblo athletes as role models and aspired to be a part of the Pack.

After originally signing to run track for the ThunderWolves, she was approached by Head Women's Lacrosse Coach Monica Potter to bring her athletic prowess and

leadership to that team, where she now has served as captain for the past two seasons. This exprience has allowed her to learn more about herself as a person and athlete.

Women's Lacrosse season begins in March, but the team works year-round to ensure they are in top physical condition. In fact, Kelly's day begins at 4:45 a.m. when she gets up and heads to campus for strength conditioning and practice in southern Colorado's ever changing weather—minus 2 and snowing one day, 70 and

sunny the next. By the time she's sitting in her first class of the day at 9 a.m., she already has put in four hours of mental and physical effort with the team. Her classes run from 9 a.m. to 2 p.m. followed by an internship with the CSU Pueblo strength and conditioning coach from 3 to 5 p.m. Then it's time to hit the weights for an hour, study, spend time with family and get some much-needed rest.

Much like her athletic career, Kelly's academic was not linear either. Originally enrolling in education and Spanish classes to pursue teaching certification, Kelly found her passion and true calling in the newly added health science degree and health coaching emphasis. The program provides a medical background needed in athletics along with the psychology needed to help athletes thrive.

Kelly's dream career as a sports psychologist working with elite and professional athletes to increase their athletic performance while managing the mental stress and strain placed upon them. "I love working with people, but also love athletics, so sports psychology just clicked for me," said Kelly.

Kelly plans on pursuing a master's degree in sports psychology to prepare her for her dream job. For now, she's hard at work finishing her bachelor's degree with the help of the Jane C. Cotner and Pueblo Kiwanis Club Foundation Scholarships.

"As a student-athlete, there are unique stressors — from the

grueling schedule, to the physical demands of practice, to performing well in the classroom," said Kelly. The gift of financial scholarships have taken the financial stress away allowing Kelly to focus on her course of study and performance on the field.

Wilson is happy to be learning what he can in class and at his internship and is hopeful that it will help him figure out his future career path.





On January 1, 2019, the CSU Pueblo Foundation, in partnership with CSU Pueblo and the CSU System, privately launched *Drive*, a Campaign for CSU Pueblo. The campaign, with a goal to raise \$100 million by 2028, represents the internal desire CSU Pueblo students and staff embody to overcome obstacles and barriers to succeed.

By the time Drive was publicly launched on March 15, 2022, the campaign had raised more than \$95 million. With six years remaining in the campaign, Foundation and University leaders decided to rebrand the campaign to *OverDrive*, and reset the goal to \$135 million.

CSU Pueblo Foundation's commitment to an additional \$35 million will support access and affordability for CSU Pueblo students and prospective students. Each year, CSU Pueblo distributes nearly \$3.5 million in scholarships to CSU Pueblo students and supports other University financial aid programs like Colorado Promise and transfer initiatives. This additional funding over the next six years will enable the Foundation to assist the University with its objective to add 1,200 new students.

"The OverDrive campaign is an extraordinary platform for all members of the CSU Pueblo community to create life changing opportunities for future and current students," said Todd Kelly, CSU Pueblo Foundation President/CEO. "This campaign allows us all to be a part of advancing a movement that provides greater access to higher education."
